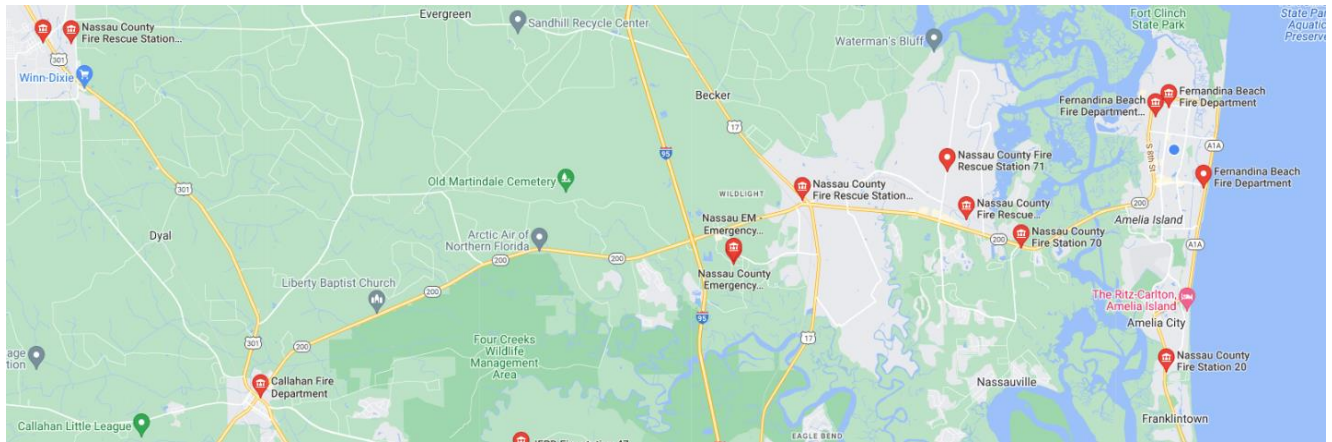

During a disaster Nassau County Emergency Management will set up a Citizen Information Center 904-548-0900 to answer questions or address specific concerns.

SPECIAL NEEDS ASSISTANCE DURING EVACUATIONS

The Florida Department of Health, in coordination with emergency management agencies, maintains a statewide registry for residents who will need assistance getting to a shelter or managing their medical needs in a shelter during a disaster.

Who should register?

1. Residents who do not have personal transportation and would not be able to get to a public emergency shelter when an evacuation is ordered.
2. Residents who plan to go to an emergency shelter when an evacuation is ordered but require assistance for their impairments or disabilities that exceeds what is available at a general population shelter.
3. Persons who are medically stable but need help with basic tasks, get support from daily home-health care, or use medical equipment that requires electricity (e.g., an oxygen concentrator), and their caregivers can register for space in a Special Medical Needs Shelter.

Attention Health Care Providers: If you are a health care provider contact SNR@flhealth.gov to obtain a login for the special needs registry to ensure you are able to use all health care provider functions.

EMERGENCY ALERT NOTIFICATION – SIGN UP

Keep informed about emergency conditions and other important community news by signing up for our Emergency Alert Notification System. This Citizen Alert system enables us to provide you with critical information quickly in a variety of situations, like

when circumstances require evacuations or sheltering-in-place for your neighborhood or create unexpected road closures.

You can receive voice-recorded alerts to your choice of home, mobile, or business phones, as well as text alerts and e-mail messages.

Register for Smart Weather Alerts to receive notifications whenever the National Weather Service issues a watch, warning, or advisory - **you select which weather conditions and which severity levels.**

Note: A "quiet period" has been enabled for weather alerts - they will not be broadcast between 9pm and 6am - except for tornado, hurricane, flash flood or tsunami warnings, which require immediate action.

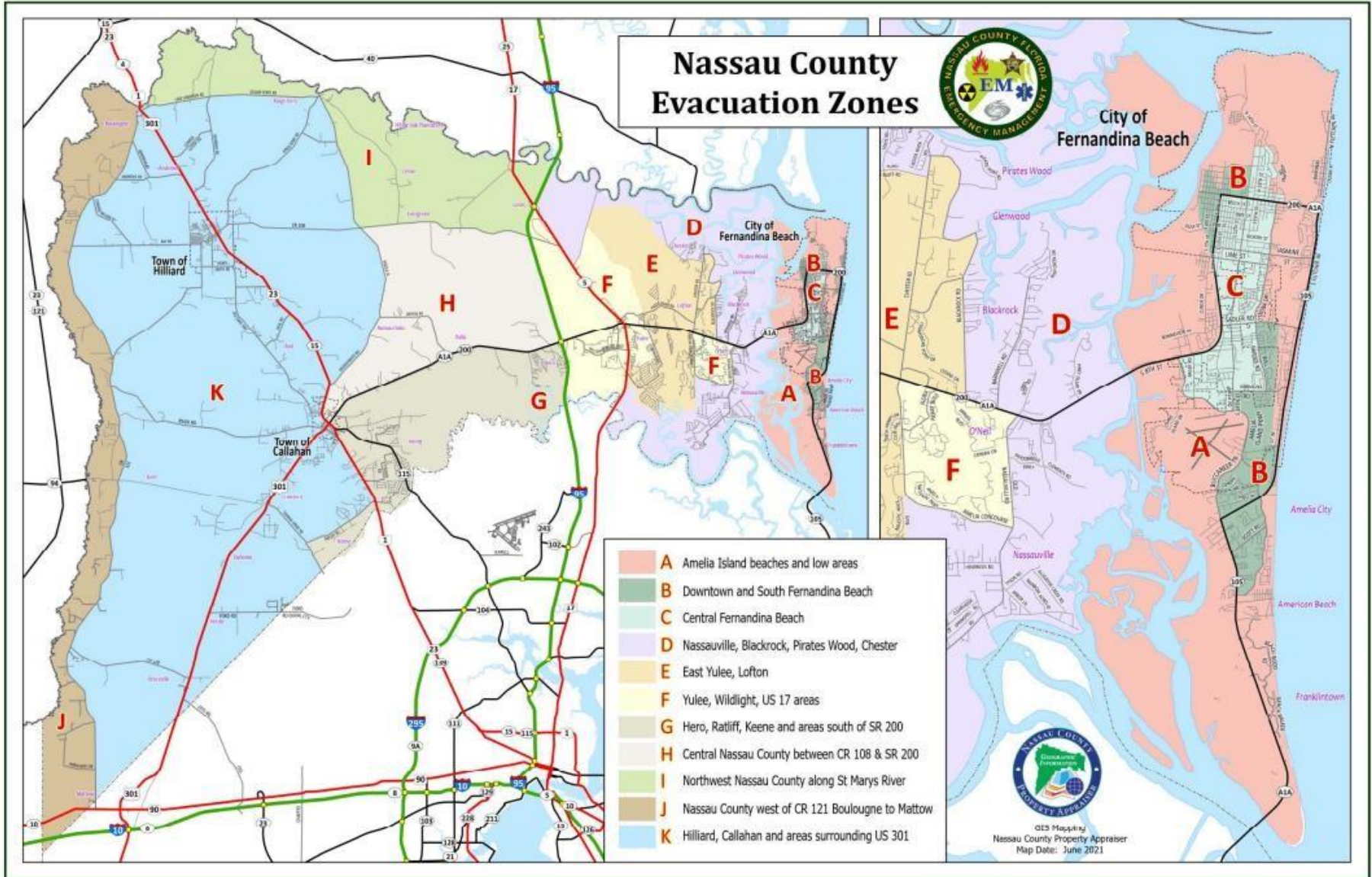
The Medical Reserve Corps (MRC) is a national network of volunteers, organized locally by Nassau County Emergency Management to improve the health and safety of their communities.

MRC provides medical and non-medical support for races and events held throughout the county. This can include first aid tents, hydration stations, and educational opportunities. MRC volunteers include medical and public health professionals, as well as other community members without healthcare backgrounds

MRC units engage these volunteers to strengthen public health, improve emergency response capabilities, and build community resiliency. They prepare for and respond to natural disasters, such as wildfires, hurricanes, and floods, as well as other emergencies affecting public health, such as disease outbreaks.

The Department of Elder Affairs has several programs to support research, services, and care for people living with Alzheimer's disease and their caregivers.

Alzheimer's Disease Initiative (ADI)

Florida's Alzheimer's Disease Initiative (ADI) provides services to meet the changing needs of individuals and families living with Alzheimer's disease and similar memory disorders. ADI respite care is available for caregivers of adults age 18 and older who have been diagnosed as having probable Alzheimer's disease or other related memory disorders where mental changes appear and interfere with the activities of daily living.

Caregivers of those living with Alzheimer's disease or related memory disorders can receive training and other ADI support services in addition to respite care.

ADI respite services include in-home, adult day care, emergency, and extended care (up to 30 days) for caregivers who serve patients with memory disorders.

The ADI provides support services that include:

- Case management
- Caregiver counseling and support groups
- Specialized medical equipment & supplies
- Caregiver training

These services are provided through the 11 Area Agencies on Aging (AAA's). For eligibility requirements and how to receive these services, you can contact your local Area Agency on Aging by calling the Elder Helpline at 1-800-96-Elder (1-800-963-5337)

Memory Disorder Clinics

Floridians of any age suspected of having a memory disorder may request that a Memory Disorder Clinic conduct diagnostic evaluations to determine probable Alzheimer's disease or related disorders. The Memory Disorder Clinics also coordinate with law enforcement agencies after a Silver Alert has been issued.

The Florida Brain Bank research program is dedicated to the coordination of brain tissue donations for critical scientific research that is aimed at ultimately curing Alzheimer's disease and other related dementias.

Enrolling in the Florida Brain Bank

Registration takes some time (plan on 6-8 weeks). All participants must be registered prior to time of death and must reside in the state of Florida at time of enrollment and of death. Basic criteria for enrollment includes the requirement for a diagnosis of Alzheimer's Disease, or any other age related dementia, that has been in place for a minimum of 12 months.

STARTING POINT BEHAVIORAL HEALTH MOBILE RESPONSE TEAM

The Mobile Response Team (MRT), in partnership with local law enforcement and county schools, provides on-demand crisis intervention services to stabilize Nassau County residents who are experiencing a behavioral health emergency. These emergencies can include suicidal thoughts or behaviors, homicidal thoughts or behaviors, extreme behavioral challenges, emergencies related to substance use, and psychotic episodes (like hallucinations, delusional content, paranoia, etc.)

Typically, an MRT call is initiated by school or law enforcement personnel via 911, which then contacts the team. The team responds to the crisis as does a member of law enforcement.

The team of professionals have access to specific tools to assess the individual. They will meet and talk with the person, the family and others in their support system. A licensed clinician decides if they should initiate the Baker Act or divert the individual to other services. The Baker Act provides individuals with emergency inpatient mental health services on an involuntary or voluntary basis for up to 72 hours.

Follow up care can include therapy, case management and medication, whatever is needed to wrap around the individual and their family.

For people who are not hospitalized, the team follows up about 72 hours after the initial call, reaching out twice a day either in person or through texts or phone calls, to ensure that the care plan is being followed.

The Rape Recovery Team (RRT) responds quickly and compassionately to survivors of sexual violence whether or not they have chosen to report the crime to police. Services are available to survivors of all genders in Duval, Nassau, and Baker Counties. WCJ's approach to support is empowerment-based, providing access to information and resources so that survivors can make the choice they feel is best for them.

Communications with Rape Recovery Team (RRT) advocates are confidential.

The Rape Recovery Team can offer support through the following services for survivors and their loved ones:

- 24-hour hotline answered by an advocate who can offer crisis intervention, information, and referrals
- 24-hour response to survivors who would like a forensic examination
- Information to assist survivors in understanding their rights and options
- Advocacy and accompaniment for medical appointments and criminal justice proceedings
- Information and referral for community resources
- Advocate-facilitated peer support groups
- Referral for mental health counseling services offered by the Women Center's

Counseling Department

For those who choose to report, the Rape Recovery Team (RRT) works collaboratively with the Sexual Assault Response Center, the State Attorney's Office and local Sheriff's Offices and Police Departments throughout Duval, Baker and Nassau Counties to ensure that survivors receive the most comprehensive services available.

The Epilepsy Services Medication Program (EMP) is a safety net program that provides epilepsy medication to clients when they need assistance paying for it. Brand name medication will only be issued when the client provides a statement from the prescriber that includes the following:

- Brand name medication is medically necessary
- Use of the generic version of the medication was attempted by the patient and was not effective or use of the generic version of the medication has not been attempted due to the severity of the patient's epilepsy

Qualification

- To qualify for the EMP the applicant must meet the following criteria:
- Be a self-declared resident of Florida
- Be uninsured, lacking insurance that covers epilepsy medication or have an insurance deductible or co-pay that s/he cannot afford, and have a net family income at or below 100% of the federal poverty guidelines
- Have no more than \$2,500 in private funds, bank accounts, or assets other than a homestead
- Not a current Medicaid recipient

Enrollment

Applicant must complete the Epilepsy Services Medication Program Application. The applicant must submit along with the application, a recent prescription for epilepsy medication, a physician statement (if applicable), and proof of the following verification documents: identity, residency, income, and insurance.

Prescriptions

In the event the CHD does not have a licensed pharmacy on site (which is the Case of the Department of Health in Nassau County, the prescription will be sent to the Bureau of Public Health Pharmacy located in Tallahassee, Florida to be filled. The client will receive the prescription via certified mail where they must sign upon receipt of the medication.

To get prescriptions filled as a member of the EMP, the client must bring a recent prescription to your county health department (CHD) or complete the online refill home delivery form:

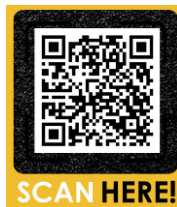

- CHILD CARE FACILITY
- LARGE FAMILY CHILD CARE HOME
- LICENSED FAMILY DAY CARE HOME

- DROP-IN
- INDOOR RECREATIONAL
- MILDLY ILL

CHILD CARE FACILITY- A childcare facility provides childcare for more than five children, unrelated to the operator. The provider also receives a payment, fee or grant for any of the children receiving care whether for profit or nonprofit. *Section 402.302(2), Florida Statutes*

Every childcare facility in the state, unless statutorily exempt, shall have an Annual license

The purpose of the program is to ensure a healthy and safe environment for the children in child-care settings and to improve the quality of their care through regulation and consultation. The department ensures that licensing requirements are met through on-going inspections of child-care facilities and homes, thus preventing the continued operation of substandard childca
